SUBJECT: A RESOLUTION FIXING AN ALTERNATE DAY FOR THE REGULAR CITY COUNCIL MEETING CURRENTLY SCHEDULED FOR THE SECOND MONDAY IN OCTOBER 2022 AND THE FOURTH MONDAY IN DECEMBER 2022

SUMMARY:

This Resolution changes the date of two 2022 Regular City Council meetings currently scheduled for the second Monday in October and the fourth Monday in December 2022 in order to accommodate the 2022 City Holiday Schedule.

PREVIOUS COUNCIL ACTION:

A Resolution changing the dates for any Regular City Council Meeting that falls on a City Holiday during the year is prepared for the first meeting in January of each year.

BACKGROUND:

Per Section 3-15 of the City Charter, *"If a regular meeting shall fall on or the evening before a City holiday, the City Council may by Resolution fix another day for such regular meeting."*

Monday, October 10, 2022 is observed as a City Holiday. The Regular Meeting scheduled for Monday, October 10, 2022 will be moved to Tuesday, October 11, 2022.

Monday, December 26, 2022 is observed as a City Holiday. The Regular Meeting scheduled for Monday, December 26, 2022 will be moved to Tuesday, December 27, 2022.

WHEREAS, the Regular City Council Meeting scheduled for the Fourth Monday in December falls on December 26, 2022, which is observed as a City Holiday; NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF PUEBLO, that:

SECTION 1.

Tuesday, October 11, 2022 is hereby fixed as the day for the Regular Meeting of the Pueblo City Council, originally scheduled for *Monday, October 10, 2022*.

SECTION 2.

Tuesday, December 27, 2022 is hereby fixed as the day for the Regular Meeting of the Pueblo City Council, originally scheduled for *Monday, December 26, 2022*.

SECTION 3.

The officers and staff of the City are authorized to perform any and all acts consistent with the intent of this Resolution to implement the policies and procedures described herein.

SECTION 4.

This Resolution shall become effective upon passage and approval.
