City Council sponsored this event in 2021 for \$500.

BACKGROUND:

City Council Members Lori Winner and Dennis Flores are requesting \$500 to support their Pueblo Mentoring Collaborative which is an arm of United Way. The Collaborative is made up of a variety of local community service agencies which include; Boys and Girls Clubs of Pueblo County, Colorado State University-Pueblo, First Presbyterian Church Mentoring, Health Solutions, Pueblo Catholic Charities, Pueblo County Youth Advisory Council, Pueblo Department of Public Health and Environment, STARS Mentoring/Friends First, Southern Colorado Youth Development, State of Grace Counseling, United Way of Pueblo County, YWCA of Pueblo, and many other service agencies.
