SUBJECT: A RESOLUTION CONFIRMING THE APPOINTMENT BY THE MAYOR OF GEORGE SAMARAS TO COMPLETE A TERM EXPIRING JUNE 30, 2023 ON THE PUEBLO ENERGY ADVISORY COMMISSION

SUMMARY:

This Resolution confirms the appointment by the Mayor of a member to complete a four-year term expiring June 30, 2023 on the Pueblo Energy Advisory Commission.

PREVIOUS COUNCIL ACTION:

On March 22, 2011, by Ordinance No. 9902, City Council amended Chapter 5 of Title II of the Pueblo Municipal Code to reconstitute the Pueblo Energy Advisory Commission. City Council has made appointments to the Pueblo Energy Advisory Commission selecting individuals to serve terms which expire during a calendar year. Amended City Charter Section 4-4 (i) now requires that such appointments be made by the Mayor, subject to confirmation by City Council.

BACKGROUND:

Due to the removal of Jeff Mara and the resignation of Allison Kipple, there are two vacancies on this board.

The application was reviewed by Mayor Gradisar who has appointed George Samaras to complete a four-year term expiring June 30, 2023.
