SUMMARY:

This Resolution confirms the appointment by the Mayor of a member to complete a three-year term expiring December 31, 2024 on the Pueblo Human Relations Commission.

PREVIOUS COUNCIL ACTION:

City Council has made appointments to the Pueblo Human Relations Commission selecting individuals to serve terms which expire during a particular calendar year. Amended City Charter Section 4-4 (i) now requires that such appointments be made by the Mayor, subject to confirmation by City Council.

BACKGROUND:

Due to the resignations of Heather Black, Aaron Lucero, Sarah Habib, and the term expiration of Laura Wiant, there are four City appointments available on the Pueblo Human Relations Committee.

The application was reviewed by Mayor Gradisar who has appointed Fred Boatwright and Richard Blair to complete terms expiring December 31, 2024.
