SUBJECT: A RESOLUTION CONFIRMING THE APPOINTMENT BY THE MAYOR OF GARY MICHELI TO SERVE A THREE-YEAR TERM EXPIRING APRIL 1, 2025 ON THE FIRE BOARD OF APPEALS

**SUMMARY:**

This Resolution confirms the appointment by the Mayor of a member to serve a three-year term expiring April 1, 2025 on the Fire Board of Appeals.

**PREVIOUS COUNCIL ACTION:**

City Council has made appointments to the Fire Board of Appeals selecting individuals to serve terms which expire during a calendar year. Amended City Charter Section 4-4 (i) now requires that such appointments be made by the Mayor, subject to confirmation by City Council.

**BACKGROUND:**

Due to the term expiration of Board Member Gary Micheli, there is one appointment available to serve a three-year term expiring April 1, 2025 on the Fire Board of Appeals.

Following an advertisement in the *Pueblo Chieftain*, social media, and an announcement on the City's webpage seeking volunteers to serve on this Board, one new application was received from Gary Micheli.

Incumbent Gary Micheli stated he would like to be considered for reappointment due to the lack of applicants. The application was reviewed by Mayor Gradisar and his recommendation is to appoint Gary Micheli.
