**SUMMARY:**

Attached for consideration is a request for sponsorship of the Goodnight Barn Foundation's 2022 Chuck Wagon Rendezvous to be held on May 20 & 21, 2022. A matching \$500 will come from the Mayor's contingencies account.

**PREVIOUS COUNCIL ACTION:**

Council has supported this event in 2017 for \$500 and 2020 for \$1,000.

**BACKGROUND:**

Council Member Heather Graham is requesting \$500 to sponsor the Goodnight Barn Foundation's 2022 Chuck Wagon Rendezvous to be held on May 20 & 21, 2022. As the wagons set up on Friday, the Barn will treat the public to living history (trappers, Kit Carson, Pike, Buffalo Soldiers, etc.), seminars on chuck wagons and more. That evening will have western music around a campfire, food trucks and some western vendors. Saturday will be the wagons cooking and serving their fare at 1 :00 pm.

Funds in the amount of \$500 would be paid from the Council Contingencies Account in the 2022 General Fund Budget to the Goodnight Barn Foundation.
