**SUMMARY:**

This resolution ratifies the joint City-County appointment of a journeyman to the Regional Building Commission's Plumbing Board of Appeals to complete a three-year term.

Joint City-County appointments to the Pueblo Regional Building Commission are made on an annual basis selecting individuals to serve three-year terms expiring on July 1<sup>st</sup> of each year. Resolutions to ratify the joint appointments are passed by each entity.
