**SUBJECT:** AN ORDINANCE ESTABLISHING EAST GENERAL AVIATION APRON REHABILITATION PROJECT NO. AP2204, TRANSFERRING \$13,545 FROM THE AIRPORT FUND, BUGETING AND APPROPRIATING \$13,545 TO PROJECT NO. AP2204, APPROVING AN AGREEMENT FOR PROFESSIONAL ENGINEERING SERVICES IN THE AMOUNT OF \$13,545 TO DIBBLE & ASSOCIATES CONSULTING ENGINEERS, INC., AN ARIZONA CORPORATION, FOR PROJECT EAST GENERAL AVIATION APRON REHABILITATION PROJECT IN CONNECTION WITH BID 17-062 RFQ – PUEBLO MEMORIAL AIRPORT ENGINEER OF RECORD AND AUTHORIZING THE MAYOR TO EXECUTE SAME

**SUMMARY:**

This Ordinance establishes Project No. AP2204, transfers and appropriates \$13,545 to the Project and approves an Agreement for Professional Engineering Services to Dibble & Associates Consulting Engineers, Inc., for engineering services for East General Aviation (GA) Apron Rehabilitation Project at the Pueblo Memorial Airport.

**PREVIOUS COUNCIL ACTION:**

City Council approved a design agreement between the City and Dibble Engineering on January 25, 2021 under Ordinance No. 9869 in the amount of \$164,617. That Ordinance also established the Taxiway E. Reconstruction Project No. AP2101.

City Council approved an agreement between the City and Dibble Engineering on July 12, 2021 under Ordinance 9961 in the amount of \$135,313.

**BACKGROUND:**

The Agreement is for the professional design services of the East GA Apron Rehabilitation project. Dibble Engineering will provide preliminary design, final design and construction documents and bidding assistance.

The East General Aviation Apron is composed of approximately 26,200 square yards of asphalt concrete pavement and is experiencing severe rutting and alligator cracking. The Dibble team will provide a simplified design documents package for the rehabilitation of the apron.

**FINANCIAL IMPLICATIONS:**

Funding in the amount of \$13,545.00 will be paid from AP2204 –East GA Apron Rehabilitation Project.

ORDINANCE NO. 10159

AN ORDINANCE ESTABLISHING EAST GENERAL AVIATION APRON REHABILITATION PROJECT NO. AP2204, TRANSFERRING \$13,545 FROM THE AIRPORT FUND, BUDGETING AND APPROPRIATING \$13,545 TO PROJECT NO. AP2204, APPROVING AN AGREEMENT FOR PROFESSIONAL ENGINEERING SERVICES IN THE AMOUNT OF \$13,545 TO DIBBLE & ASSOCIATES CONSULTING ENGINEERS, INC., AN ARIZONA CORPORATION, FOR PROJECT EAST GENERAL AVIATION APRON REHABILITATION PROJECT IN CONNECTION WITH BID 17-062 RFQ – PUEBLO MEMORIAL AIRPORT ENGINEER OF RECORD AND AUTHORIZING THE MAYOR TO EXECUTE SAME

BE IT ORDAINED BY THE CITY COUNCIL OF PUEBLO, that:

SECTION 1.

East General Aviation Apron Rehabilitation Project No. AP2204 is hereby established.

SECTION 2.

Funds in the amount of \$13,545 are hereby transferred from the Airport Fund to the East General Aviation Apron Rehabilitation Project No. AP2204.

SECTION 3.

Funds in the amount of \$13,545 are hereby budgeted and appropriated to the East General Aviation Apron Rehabilitation Project No. AP2204.

SECTION 4.

An Agreement for Professional Engineering Services (“Agreement”), a copy of which is attached hereto and made part hereof by reference, by and between the City of Pueblo, a Municipal Corporation, to provide engineering services for the East General Aviation Apron Rehabilitation Project at Pueblo Memorial Airport, after having been approved as to form by the City Attorney, is hereby approved.

SECTION 5.

The Mayor is authorized to execute the Agreement on behalf of the City of Pueblo, a Municipal Corporation, and the City Clerk is shall affix the seal of the City thereto and attest same.

SECTION 6.

The officers and staff of the City are authorized to perform any and all acts consistent with the intent of the Ordinance and the attached Agreement to implement the policies and procedures described therein.

**SECTION 7.**

This Ordinance shall become effective on the date of final action by the Mayor and City Council.
