SECTION 1.

The attached Revocable Permit is authorized to be issued to the Pueblo Chamber of Commerce for the use of Grand Ave. from City Center Dr. to Union Ave., D St. from Victoria Ave to Main St., C St. from Victoria Ave to Main St., Union Ave. from City Center Dr. to B St., Alan Hamel Ave. from Union Ave. to Main St., from September 21, 2022, at 7:00 a.m. until September 26, 2022, at 5:00 p.m. to conduct the Annual Chile and Frijoles Festival.

SECTION 2.

The use of the public right-of-way granted hereby is subject to all limitations, terms, and conditions set forth in the attached Revocable Permit.

SECTION 3.

The officers and staff of the City are authorized to perform any and all acts consistent with the intent of this Resolution to implement the policies and procedures described herein.


SECTION 4.
