SUMMARY:

This Resolution confirms the appointment by the Mayor of a member to the to complete a four-year term expiring June 30, 2025.

PREVIOUS COUNCIL ACTION:

On March 22, 2011, by Ordinance No. 9902, City Council amended Chapter 5 of Title II of the Pueblo Municipal Code to reconstitute the Pueblo Energy Advisory Commission. City Council has made appointments to the Pueblo Energy Advisory Commission selecting individuals to serve terms which expire during a calendar year. Amended City Charter Section 4-4 (i) now requires that such appointments be made by the Mayor, subject to confirmation by City Council.

BACKGROUND:

Due to the resignations of Gregory George and Allison Kipple, there are two vacancies on this Commission. Following an announcement on the City's webpage and social media seeking volunteers to serve on this committee, one application was received. Mayor Gradisar reviewed the application and appointed Mr. Percival.
