**SUMMARY:**

Attached is a resolution awarding a construction contract to Martin Marietta Materials, Inc., for Project No. 22-079 Asphalt Paving – Phase 4.

**BACKGROUND:**

In general, this project will consist of milling and asphalt overlaying of the streets and associated construction on Ridge Drive between Eagleridge Boulevard and just north of Highway 50 and Alan Hamel Avenue from Santa Fe Avenue west approximately 400 feet.

A RESOLUTION AWARDDING A CONSTRUCTION CONTRACT IN THE AMOUNT OF \$1,032,873.79 TO MARTIN MARIETTA MATERIALS, INC., AND SETTING FORTH \$103,287.38 FOR CONTINGENCIES, FOR PROJECT NO. 22-079 ASPHALT PAVING – PHASE 4 AND AUTHORIZING THE PURCHASING AGENT TO EXECUTE SAME

WHEREAS, competitive bids for the Project No. 22-079 Asphalt Paving – Phase 4 have been received and examined; and

WHEREAS, the proposal of Martin Marietta Materials, Inc., was the only bid determined to be responsive, and the Committee of Awards recommends to the City Council that it authorize Project No. 22-079 to be performed; NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF PUEBLO, that:

SECTION 1.

City Council authorizes Project No. 22-079 Asphalt Paving – Phase 4 to be performed, and the contract for said project is hereby awarded to Martin Marietta Materials, Inc., in the amount of \$1,032,873.79.

SECTION 2.

Funds for Project 22-079 shall be from Project No. CI2204 Street Rehabilitation Project.

SECTION 3.

The Purchasing Agent is hereby authorized to execute said contract on behalf of the City of Pueblo, a Municipal Corporation, and the City Clerk shall affix the seal of the City thereto and attest the same.

SECTION 4.

In addition to the amount of the bid set forth, as aforementioned, an additional amount as stipulated in this section is hereby established for contingencies and additional work.

Contingencies and Additional Work.....\$103,287.38

SECTION 5.

The officers and staff of the City of Pueblo are authorized to perform any and all acts consistent with the intent of this Resolution and the contract to implement the transactions described therein.


SECTION 6.

This Resolution shall become effective immediately upon passage and approval.
