SUMMARY:

Attached for consideration is a request for support of the Song of Pueblo performance for all Pueblo City Schools third graders which will take place at the Sangre de Cristo Arts Center Theater on Wednesday, September 21, 2022.

BACKGROUND:

City Council Member Vicente Martinez Ortega is requesting \$3,000 in support of a Song of Pueblo performance on September 21, 2022. The funds will cover the cost of the seven performers, rehearsals, and the venue. Together with Ms. Smith from Pueblo City Schools, transportation has been arranged for students to attend the concert. This educational partnership enhances student learning and performance art.
