READING AND APPROVAL OF MINUTES:

- Regular meeting of Tuesday, April 14, 2015.

Commission Action: Motion to dispense with the reading and approve the minutes of the regular meeting dated Tuesday, April 14, 2015 as distributed.

CONSENT AGENDA

The following items are considered to be routine by the Civil Service Commission and will be passed and approved by one motion. There will be no separate discussion of these items unless a Commissioner so requests; in which event, the item shall be removed and considered as a regular item.

1. Receive and file the following status reports on current recruitments:
 - a. Fire Captain - (Recruitment required every year per Civil Service Rule 29) – We received 31 applications, and all were qualified. The written exam was held on March 3, 2015, and all 31 candidates appeared to take the exam. Seven candidates passed the exam and 24 candidates failed. The eligible list for this position will be signed at this meeting.
 - b. Police Patrol Officer – (Recruitment due to exhaustion of eligible list) – The written exam was held on March 24, 2015. Seventy five persons were scheduled for the exam, and 59 appeared to take the exam. Thirty eight candidates passed the exam and 21 failed. The eligible list for this position will be signed at this meeting.
 - c. Assistant Fire Chief - (Recruitment required every year per Civil Service Rule 29) – Internal recruitment began on February 22, 2015 and ended on March 15, 2015. The written exam was held on April 14, 2015. Nine candidates were scheduled and seven appeared to take the exam. All seven candidates passed the exam. We received two appeals on two questions. The testing company is currently reviewing those appeals.

- d. Emergency Services Dispatcher - (Recruitment due to exhaustion of eligible list) – The written exam was held on April 21, 2015. Forty three candidates were scheduled, and 34 appeared to take the exam. Thirty one candidates passed and three failed. The eligible list for this position will be signed at this meeting.
 - e. Street Inspector - (Recruitment due to employee retirement) – The written exam was held on April 16, 2015. All six qualified candidates appeared to take the exam, and all passed. We are currently in the review period for appeals.
 - f. Area Crew Leader - (Recruitment due to employee retirement) – We received 11 applications for this position, and all were qualified. The written exam is scheduled for May 12, 2015.
 - g. Civil Engineer/Drainage - (Recruitment due to employee separation) – The external recruitment began on April 12, 2015 and ended on May 3, 2015. We received eight applications, and five were qualified. We are currently in the appeal period for rejections.
 - h. Crime Analyst - (Recruitment due to employee resignation) – The Commission gave permission, and a T&E evaluation was conducted on the one qualified candidate. The eligible list for this position will be signed at this meeting.
 - i. Fire Engineer - (Recruitment required every year per Civil Service Rule 29) – The internal recruitment began on March 22, 2015 and ends on April 12, 2015. We received 14 applications, and all were qualified. The written exam is scheduled for May 14, 2015.
 - j. Accountant II - (Recruitment due to employee promotion) – The internal recruitment began on April 12, 2015 and ended on April 26, 2015. We received four applications. The applications are currently being screened.
 - k. Benefits Coordinator - (Recruitment due to employee demotion) – The internal recruitment began on April 20, 2015 and ended on May 4, 2015. We received four applications, and three of those were qualified. We are currently in the appeal period for the rejection.
 - l. Parks Supervisor - (Recruitment due to employee transfer) – The external recruitment begins on May 10, 2015 and ends on May 31, 2015.
 - m. Police Sergeant - (Recruitment required every year per Civil Service Rule 29) – The internal recruitment begins on May 10, 2015 and ends on May 31, 2015. The written exam is scheduled for June 16, 2015.
