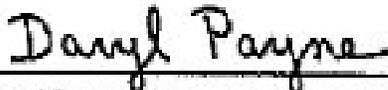
For the record, it was determined that there was no one present in opposition to this modification of premises.

Club Ice, LLC members, Ed Sena, and Jessica Sena, 3313 Petalina Court, were sworn in and answered questions for this modification of premises. Ms. Sena explained there is currently an existing fenced-in patio that is unlicensed. Also, the restaurant portion of the building was sublet to another individual and also not licensed. The sublease has expired and Mr. and Ms. Sena desire to operate the restaurant portion with the existing bar business that is conducted. Board members questioned the applicant specifically about security control for the patio. Ms. Sena stated they will be installing security cameras and have doormen in the patio area.

Ms. Shafer seconded by Mr. Ferris moved to Approve Permit Application and Report of Changes: Modification of Premises – Tavern Liquor License – Club Ice, LLC d/b/a Club Ice. Roll Call: Ayes— Ferris, Pullaro, Rose, and Shafer. Motion carried unanimously.
