## CONSENT AGENDA

  - a. **Accountant I** (Recruitment due to an employee resignation) – The internal recruitment began on July 27, 2017 and ends on August 10, 2017. We had 0 applications as of the date this agenda was prepared.
  - b. **Building and Grounds Maintenance Mechanic-HVAC** (Recruitment due to an employee retirement) – The promotional recruitment began on July 11, 2017 and ended on July 25, 2017. We received 0 applications. The external recruitment began on July 26, 2017 and ends on August 16, 2017. We had 2 applications of the date this agenda was prepared. The written exam date and time is to be determined.
  - c. **Business Systems Analyst** (Recruitment due to an employee separation) – The promotional recruitment began on July 14, 2017 and ended on July 28, 2017. We received 0 applications. The external recruitment began on July 30, 2017 and ends on August 20, 2017. We received 9 as of the date this agenda was prepared. The written exam is scheduled for September 5, 2017.

- d. **Code Enforcement Officer** (Recruitment due to an employee demotion) – The external recruitment began on July 25, 2017 and ends on August 15, 2017. We received 105 applications as of the date this agenda was prepared. The written exam is scheduled for August 29, 2017.
- e. **Emergency Services Dispatcher** (Recruitment due to current and anticipated vacancies) – The external recruitment began on August 1, 2017 and ends on August 22, 2017. We received 40 applications as of the date this agenda was prepared. The written exam is scheduled for September 6, 2017.
- f. **Painter** (Recruitment due to an employee promotion) - The external recruitment began on June 15, 2017 and ended on July 6, 2017. We received 15 applications. The written exam was administered on July 26, 2017. The eligibility list will be presented to the Civil Service Commission for certification during this meeting.
- g. **Police Captain** (Recruitment due to anticipated vacancies) – The promotional recruitment began on July 10, 2017; the City Manager requested that the posting be inactivated on July 11, 2017 to address concerns with the job description. The recruitment resumed on July 20, 2017 and ended on August 3, 2017. We received 5 applications. The written exam is scheduled for August 16, 2017.
- h. **Police Chief** (Recruitment due to anticipated retirement) – The recruitment for this unclassified position began on July 3, 2017 and ended on August 1, 2017. One application was received, and forwarded to the Human Resources Department.
- i. **Police Sergeant** (Recruitment due to anticipated vacancies) – The promotional recruitment began on July 10, 2017; the City Manager requested that the posting be inactivated on July 11, 2017 to address concerns with the job description. The recruitment resumed on July 20, 2017 and ended on August 3, 2017. We received 38 applications. The written exam is scheduled for August 15, 2017.
- j. **Secretary to City Manager** (Recruitment due to employee resignation) – The recruitment for this unclassified position began on August 1, 2017 and ends on August 15, 2017. As to date, 78 applications received and forwarded to the City Manager’s Office.
- k. **Senior PC/Network Technician** (Recruitment due to employee promotion) – The promotional recruitment began on July 6, 2017 and ended on July 20, 2017. We received 1 qualified applicant; a T&E was performed on July 25, 2017. The eligibility list will be presented to the Civil Service Commission for certification during this meeting.
- l. **Tax Auditor** (Recruitment due to an employee separation) – The external recruitment began on June 15, 2017 and ended on July 6, 2017. We received 23 applications. The written exam was administered on July 25, 2017. The eligibility list will be presented to the Civil Service Commission for certification during this meeting.
