- d. **Civil Engineer/Construction** (Recruitment due to an employee retirement) – The promotional recruitment began on August 6, 2017 and ended on August 20, 2017. We received 4 applications; 2 applicants were qualified. The eligibility list will be presented to the Civil Service Commission for certification during this meeting
- e. **Crime Analyst** (Recruitment due to an employee discharge) – The external recruitment began on August 27, 2017 and ends on September 17, 2017. We received 21 applications as of the date this agenda was prepared. The written exam is scheduled for October 2, 2017.
- f. **Code Enforcement Officer** (Recruitment due to an employee demotion) – The external recruitment began on July 25, 2017 and ended on August 15, 2017. We received 183 applications. The written exam was administered on August 29, 2017. The eligibility list will be presented to the Civil Service Commission for certification during this meeting.
- g. **Emergency Services Dispatcher** (Recruitment due to current and anticipated vacancies) – The external recruitment began on August 1, 2017 and ended on August 22, 2017. We received a total of 190 applications. The CitiCall exams were administered on August 30, August 31, September 1, and September 6. The written test was administered on September 6, 2017. The eligibility list will be presented to the Civil Service Commission for certification during this meeting.
- h. **Emergency Services Dispatch Supervisor** (Recruitment due to employee resignation) – The promotional recruitment began on August 24, 2017 and ended on September 7, 2017. We received a total of 4 applications; they are currently under review. The written exam will be administered on September 20, 2017.
- i. **Police Captain** (Recruitment due to anticipated vacancies) – The promotional recruitment began on July 10, 2017; the City Manager requested that the posting be inactivated on July 11, 2017 to address concerns with the job description. The recruitment resumed on July 20, 2017 and ended on August 3, 2017. We received a total of 5 applications; 3 were qualified. The written exam was administered on August 16, 2017. The eligibility list will be presented to the Civil Service Commission for certification during this meeting.
- j. **Police Sergeant** (Recruitment due to anticipated vacancies) – The promotional recruitment began on July 10, 2017; the City Manager requested that the posting be inactivated on July 11, 2017 to address concerns with the job description. The recruitment resumed on July 20, 2017 and ended on August 3, 2017. We received 38 applications. The written exam was administered on August 15, 2017. The eligibility list will be presented to the Civil Service Commission for certification during this meeting.
- k. **Secretary to City Manager** (Recruitment due to employee resignation) – The recruitment for this unclassified position began on August 1, 2017 and ended on August 15, 2017. We received 182 applications; they were forwarded to the City Manager's Office.
