
6 PERMIT APPLICATION & REPORT OF CHANGES – MANAGER’S REGISTRATION (HOTEL AND RESTAURANT) — BRINKER RESTAURANT CORPORATION D/B/A CHILI’S GRILL & BAR (MICHAEL SAIZ REPLACES GREGORY DIAZ)

New Manager Michael Saiz, 132 Sterling Place, Pueblo West, CO was sworn in and answered questions from the Board. The moral character questions were directed to Mr. Saiz. Currently Chili’s employs 45 – 55 employees depending on the time of year. There are currently 30 employees that serve liquor. Mr. Saiz was unaware of any convictions for current employees. No background checks are performed. Approved forms of identification were described and examples given by Mr. Saiz. Per Chili’s policy, anyone appearing under age 30 will have their identification checked. The moral character of Mr. Saiz was found to be satisfactory to the Board. Employees attend Responsible Alcohol Service training through ServSafe.

Ms. Shafer, seconded by Ms. Harrison, moved to approve the Manager’s Registration (Hotel & Restaurant) for Brinker Restaurant Corporation d/b/a Chili’s Grill & Bar. Roll Call: Ayes — Harrison, Pullaro, Rose, Shafer, and Sowinski. Motion carried 5-0.
