Hamburgers, hot dogs, and sausage will be available for attendees. Approved forms of identification were described and examples given. Twelve Security Guards from Titan Security will be on site. There are two entry/exit points. The area is fenced and additional snow fencing will be utilized. Security will walk the perimeter. Wristbands will be utilized for bar patrons.

Pizza and concession items will be available. Mr. Groves is considering hiring a caterer for the event. Approved forms of identification were described and examples given. Anyone wishing to purchase liquor will be have their identification checked and wristbands will be utilized for bar patrons. There is one entry/exit point for this event. There is a back door to the facility which patrons will not have access to and will remain locked. There is a maximum of 35 attendees per event.


