Event Manager, Jeff Ross, 421 West Gateway Drive, Pueblo West, CO was sworn in and answered questions from the Board. This event will be Bike Night at Harley Davidson, proceeds go to veterans and paying the Motorcycle Clubs bills. There will be one liquor distribution points with two servers. A food vendor, serving hamburgers, cheeseburgers, hot dogs, and sloppers, will be on site. Approved forms of identification, and examples given. Everyone's ID will be checked, and wristbands given. Two people will be providing security. No liquor is allowed off premise. Premise is secured by barriers with crime scene tape, rope, or water barrels. Expecting 250 people.


