Executive Director, Abigail Krause, 3455 Nuckolls Avenue, and Event Manager, Noel Zant, 3455 Nuckolls Avenue were sworn in and answered questions from the Board. This is a Summer Concert Series at the Zoo Event. Proceeds will go towards operations of the Zoo. There will be one liquor distribution point with 2-4 servers. The food will be provided by the café, offering chicken wraps, salads, and sandwiches. Approved forms of identification, and examples given.
