1. Call to Order, Chair Steve Nawrocki

2. Black Hills Energy Presentation Reflection, Chair Steve Nawrocki

Discussion about the BHE presentation and as well as an update about the Pueblo Community Health Center’s newest building being Net Zero energy as a tangible example of BHE incentives.

3. Commission Structure Facilitation, Edgie Walrath
