From Laura Leyba:

Far South Park was renamed JJ Raigoza Park in 1997. He was a Navy veteran of Viet Nam, health planner for the Community Action Agency, developed and directed the first Neighborhood Health Care Program, appointed to the White House Conference on Families (1980), was on the Colorado Advisory Council on Alcohol and Drug Abuse (1981-1989), member of Keating Learning Center Board, and member of the Developmental Disability Mental Health Consortium. He died September 14, 1994.

As of this email, there is no ADA parking at this park. I hope we can help change that.

I just read the 2023 annual report for the library and it says the Barkman & Lucero branches will be renovated and/or expanded. Eastside Streetscape Study (7/08/21) and [Laura] was reminded about an issue that came up while volunteering with Parks & Rec. In the winter, the restrooms are locked because P&R shuts off the water and the toilets aren't flushable. This is a major problem for everyone, including people with disabilities. Do any of you know if it's being addressed? I propose that a possible solution is to install vault toilets in the parks. When I worked for Colorado Parks & Wildlife (CPW), we took care of all the vaults at Lake Pueblo and they're open year round.

Lamb Branch parking issue: Laura

Belmont Elementary park; lack of handicapped parking;

- **Handicapped Office in the basement of the county courthouse was intended to be a liaison between people with disabilities and any county services available in the building.
