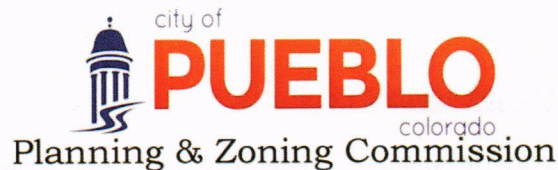

1. 2022-2026 Proposed Capital Improvement Plan

Presented by Lynn Miller, City of Pueblo Finance Dept, and Laura Solano, City of Pueblo Chief of Staff.

The first phase of the Capital Improvement Plan was presented to the commission by Lynn Miller and Laura Solano. The items below were highlighted:

- Page 3 of the Capital Improvement Plan regarding compliance.
- Proposed update in addition to the Capital Improvement Plan will be presented to City Council on October 12, 2021. Per the Charter CIP must be approved before December 1st.
- Mayor has proposed to spend 10 million dollars on roads in 2022.
- Conservation Trust Fund- Parks project will be funded based on highest priority. Highest priority currently is to provide one ADA compliant playground.


No changes were requested from the Planning and Zoning Commission.
