- 1 The Business cannot legally sell tobacco products, other than cigarettes, in the City of Pueblo without a Non-Cigarette Tobacco Retailer License.
2 The Non-Cigarette Tobacco Retailer License must be renewed every year and applicant must apply for renewal thirty (30) days before the expiration date of the Non-Cigarette Tobacco Retailer License.
3 If the business is in Violation of Section 9-15-1 through 9-15-18, and Section 11-1-209 of the Pueblo Municipal Code, the applicant may be fined and the license may be suspended or revoked.
4 The applicant is responsible for instructing his or her employees that selling tobacco products to a minor is against the law.
5 Any employee selling tobacco products to a minor may cause the business to be fined and/or have its license suspended, or revoked due to a violation under the laws of the City of Pueblo.
6 The business will be subject to inspection for compliance of Section 9-15-1 through 9-15-18, and Section 11-1-209 of the Pueblo Municipal Code, which may involve the use of minors under the supervision of law enforcement to ensure that the applicant's business is not selling tobacco products to minors.
7 Licensees shall stock and/or display all non-cigarette tobacco products in a manner that the product is inaccessible to customers without the assistance of a retail clerk; requiring direct face to face exchange of the non-cigarette tobacco product from business employee to customer

READ CAREFULLY BEFORE SIGNING.

Under penalty provided by law, the applicant states that each of the above questions has been truthfully answered to the best of the knowledge of the applicant. Applicate agrees to operate this business accoring to the law and that the rights and responsibilities conferred to the license, if grant, cannot be assigned to another. Any lack of access to any portion of a licensed premise during inspection will be deemed a refusal to permit inspection. Such refusal is grounds for revocation of this license.
