RE: Jurat and Form of Acknowledgments

Various documents which require an acknowledgment or oath or affirmation must be completed in conformity with applicable legal requirements. The form of acknowledgments is established by the Uniform Recognition of Acknowledgments Act, C.R.S. §12-55-201 et seq. (the "Act") which all Colorado notaries should be familiar with. In order to assist you and the City's Administrative Technicians who typically notarize documents, we provide the following:

(A) A "JURAT" is a clause at the end of an affidavit after the signature of the affiant, showing where and by whom it was sworn to or affirmed. The qualified officer taking the oath must place the person under his oath or affirmation and have signed in the presence of the qualified officer. In a Jurat, the signer is stating that the information in the document is true and correct. The signer must be placed under oath and the document must be signed in the presence of the Notary. Various statutes may prescribe the exact form required. However, generally these will include at least the following content:

(B) An "ACKNOWLEDGMENT" is a declaration or admission of a person's acts and deeds before a qualified official. The person taking an acknowledgment shall certify that the person acknowledging appeared before him and acknowledged he executed the instrument; and,
